The terms "we", "us" and "our" refer to M.S. Tours, Inc. dba Main Street Tours and dba Main Street Experiences. The term "you" "participant" customer" refers to the customer visiting our website, and/or booking a reservation through

YOUR ACCEPTANCE OF THESE TERMS AND CONDITIONS

By booking your arrangement with us, you are agreeing to be bound by the terms of this Agreement and any additional terms and conditions of any Supplier that are applicable to your booking and travel arrangements. It is the responsibility of each participant to read our Terms and Conditions in its entirety.
